## Attendance Policy

'Attend today, achieve tomorrow'

Review period: 2 Yearly
Date policy last reviewed: September 2023
Person Responsible for Policy: Headteacher with Attendance Officer

## 1. Aims

We are committed to meeting our obligation with regards to school attendance through our whole-school culture and ethos that values good attendance, including:

- Promoting good attendance
- Reducing absence, including persistent and severe absence
- Ensuring every pupil has access to the full-time education to which they are entitled
- Acting early to address patterns of absence
- Building strong relationships with families to ensure pupils have the support in place to attend school

We will also promote and support punctuality in attending lessons.

## 2. Legislation and guidance

This policy meets the requirements of the working together to improve school attendance from the Department for Education (DfE), and refers to the DfE's statutory guidance on school attendance parental responsibility measures. These documents are drawn from the following legislation setting out the legal powers and duties that govern school attendance:

- Part 6 of The Education Act 1996
- $\quad$ Part 3 of The Education Act 2002
- Part 7 of The Education and Inspections Act 2006
- The Education (Pupil Registration) (England) Regulations 2006 (and 2010, 2011, 2013, 2016 amendments)
- The Education (Penalty Notices) (England) (Amendment) Regulations 2013

It also refers to:

- School census guidance
- Keeping Children Safe in Education
- Mental health issues affecting a pupil's attendance: guidance for schools


## 3. Roles and responsibilities

### 3.1 The governing board

The governing board is responsible for:

- Promoting the importance of school attendance across the school's policies and ethos
- Making sure school leaders fulfil expectations and statutory duties
- Regularly reviewing and challenging attendance data
- Monitoring attendance figures for the whole school
- Making sure staff receive adequate training on attendance
- Holding the headteacher to account for the implementation of this policy


### 3.2 The Headteacher

The Headteacher is responsible for:

- Implementation of this policy at the school
- Monitoring school-level absence data and reporting it to governors
- Supporting staff with monitoring the attendance of individual pupils
- Monitoring the impact of any implemented attendance strategies
- Issuing fixed-penalty notices, where necessary
- Leading attendance across the school
- Offering a clear vision for attendance improvement
- Evaluating and monitoring expectations and processes
- Having an oversight of data analysis
- Devising specific strategies to address areas of poor attendance identified through data
- Building relationships with parents/carers to discuss and tackle attendance issues
- Creating intervention reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families


### 3.4 The Attendance Officer

The school attendance officer is responsible for:

- Monitoring and analysing attendance data (see section 7)
- Benchmarking attendance data to identify areas of focus for improvement

Providing regular attendance reports to school staff and reporting concerns about attendance to the designated senior leader responsible for attendance and the Headteacher

Working with education welfare officers to tackle persistent absence

- Advising the Headteacher when to issue fixed-penalty notices


### 3.5 Class teachers

Class teachers are responsible for recording attendance on a daily basis, using the correct codes, and submitting this information to the school office at the beginning of the morning and afternoon sessions.

### 3.6 School Admin staff

School admin staff will:
Take calls from parents/carers about absence on a day-to-day basis and record it on the school system

### 3.7 Parents/carers

Parents/carers are expected to:

- Make sure their child attends every day, on time

Call the school to report their child's absence before 8.45 on the day of the absence and each subsequent day of absence), and advise when they are expected to return

- Provide the school with more than 1 emergency contact number for their child and ensure this is kept up to date
- Ensure that, where possible, appointments for their child are made outside of the school day


### 3.8 Pupils

Pupils are expected to:

- Attend school every day, on time


## 4. Recording attendance

### 4.1 Attendance register

We will keep an attendance register, and place all pupils onto this register.
We will take our attendance register at the start of the first session of each school day and once during the second session. It will mark whether every pupil is:

- Present
- Attending an approved off-site educational activity
- Absent
- Unable to attend due to exceptional circumstances

See appendix 1 for the DfE attendance codes.

We will also record:
Whether the absence is authorised or not

- The nature of the activity if a pupil is attending an approved educational activity
- The nature of circumstances where a pupil is unable to attend due to exceptional circumstances

Pupils must arrive in school by 8.40am, on each school day.
The register for the first session will be taken at 8.45 am and will be kept open until 8.50 am . The register for the second session will be taken after pupils return from lunch (see timetable)

### 4.2 Unplanned absence

The pupil's parent/carer must notify the school of the reason for the absence on the first day of an unplanned absence by 8.45 am or as soon as practically possible by calling the school office. (see also section 7 ).

We will mark absence due to physical or mental illness as authorised unless the school has a genuine concern about the authenticity of the illness.

Where the absence is longer than 5 days or there are doubts about the authenticity of the illness, the school will ask for medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.
If the school is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised and parents/carers will be notified of this in advance.

### 4.3 Planned absence

Attending a medical or dental appointment will be counted as authorised as long as the pupil's parent/carer notifies the school in advance of the appointment and provides evidence such as an appointment card or text.

However, we encourage parents/carers to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.
The pupil's parent/carer must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 5 to find out which term-time absences the school can authorise.

Parents/carers can obtain a request for leave form from the school office to notify of any planned absences.

### 4.4 Lateness and punctuality

A pupil who arrives late:

- Before the register has closed will be marked as late, using the appropriate code - before 9:15am - L
- After the register has closed will be marked as absent, using the appropriate code - after 9:15am - U

A U Mark is an unauthorised morning and will have an impact on your child's overall attendance percentage.
The school will closely monitor and regularly run reports on pupils that are late. Any pupils identified as consistently being late, their parents/carers will be contacted and any barriers discussed. The school will also write to parents/carers and make them aware of any missed learning due to continuous lateness.

### 4.5 Following up unexplained absence

Where any pupil we expect to attend school does not attend, or stops attending, without reason, the school will:
Call the pupil's parent/carer on the morning of the first day of unexplained absence to ascertain the reason and explanation to ensure proper safeguarding action is taken where necessary. If the school cannot reach any of the pupil's emergency contacts, the school may visit home, contact pupil welfare or contact the police

Identify whether the absence is approved or not
Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained - this will be no later than 5 working days after the session

Call the parent/carer on each day that the absence continues without. If absence continues, the school will
consider involving an education welfare officer

### 4.6 Reporting to parents/carers

The school will regularly inform parents/carers about their child's attendance and absence levels on the bi-annual reports Pupils whose attendance falls below National Average of $93 \%$ will receive an attendance reminder and an offer of support from the pastoral team should they need it.

## 5. Authorised and unauthorised absence

### 5.1 Approval for term-time absence

Term times are for education. This is the priority. Children and families have 175 days off school to spend time together, including weekends and school holidays. The Headteacher will rightly prioritise attendance. Generally, absences will not be granted during term time and will only be authorised by the head teacher in exceptional circumstances. A leave of absence is granted at the headteacher's discretion, including the length of time the pupil is authorised to be absent for.

At Boundary we define 'exceptional circumstances' as follows:
Exceptional circumstances are one off events which are unavoidable:

- Death or terminal illness of a close relative

Family needs arising from service in the armed forces or from a parent working abroad where it is evidenced the individual will not be in receipt of any leave in the near future that coincides with school holidays.

- Wedding or funeral of a close relative
- Religious observance
- Sporting events or performing arts competitions at county or national level, if the child is participating
- Graduation ceremony of an immediate family member
- A housing crisis which prevents attendance.


## Unauthorised absence

Unacceptable reasons for absence which will be unauthorised, include:

- Days out
- Holidays in term time
- $\quad$ Shopping
- Hair cut
- Airport visits
- Birthday treats
- Looking after brothers and sisters at home
- Non-urgent medical or dental appointments
- Oversleeping
- Parents/carers working

Please note that the decision to authorise absences rests with school and not parents.

The school considers each application for term-time absence individually, taking into account the specific facts, circumstances and relevant context behind the request.

Any request should be submitted as soon as it is anticipated and, where possible, at least 4 weeks before the absence, and in accordance with any leave of absence request form, accessible via the school office. The headteacher may require evidence to support any request for leave of absence.
Valid reasons for authorised absence include:
Illness (including mental illness) and medical/dental appointments (see sections 4.2 and 4.3 for more detail)

- Religious observance - where the day is exclusively set apart for religious observance by the religious body to ${ }^{\bullet}$ which the pupil's parents/carers belong. If necessary, the school will seek advice from the parents'/carers' religious body to confirm whether the day is set apart

Traveller pupils travelling for occupational purposes - this covers Roma, English and Welsh gypsies, Irish and Scottish travellers, showmen (fairground people) and circus people, bargees (occupational boat dwellers) and new travellers. Absence may be authorised only when a traveller family is known to be travelling for occupational purposes and has agreed this with the school, but it is not known whether the pupil is attending educational provision

### 5.2 Legal sanctions

The school or local authority can fine parents/carers for the unauthorised absence of their child from school, where the child is of compulsory school age.
If issued with a fine, or penalty notice, each parent/carers must pay $£ 60$ within 21 days or $£ 120$ within 28 days. The payment must be made directly to the local authority.

Penalty notices can be issued by a headteacher, local authority officer or the police.
The decision on whether or not to issue a penalty notice may take into account:
The number of unauthorised absences occurring within a rolling academic year

- One-off instances of irregular attendance, such as holidays taken in term time without permission
- Where an excluded pupil is found in a public place during school hours without a justifiable reason

If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

## 6. Strategies for promoting attendance

The school celebrates attendance each week during their Friday celebration assembly and the class with the best attendance receive extra play time. The school has a vibrant attendance display in the hall to show the best class of the week.
In each classroom the certificates earnt by the class are displayed and attendance achievements are shared on the half termly newsletter.

At the end of each half term, the children who have $100 \%$ attendance receive a special $100 \%$ attendance badge. There are 6 badges to collect across the academic year and the children strive to get all 6 .
At the end of the year, the children who have $100 \%$ attendance for the year are invited to a $100 \%$ attendance party which is organised by Blackpool Council. Each child receives a medal and a certificate at the party.

## 7. Attendance monitoring

### 7.1 Monitoring attendance

The Attendance Officer and Pupil Welfare Officer will
Monitor attendance and absence data half-termly, termly and yearly across the school and at an individual pupil level

Identify whether or not there are particular groups of children whose absences may be a cause for concern

- Carry out first day home visits if we have no contact from parents/carers and the child is absent

Pupil-level absence data will be collected each term and published at national and local authority level through the DfE's school absence national statistics releases. The underlying school-level absence data is published alongside the national statistics. The school will compare attendance data to the national average, and share this with the governing board.

### 7.2 Analysing attendance

The Attendance Officer and Pupil Welfare Officer, with the Headteacher, will
Analyse attendance and absence data regularly to identify pupils or cohorts that need additional support with their attendance, and use this analysis to provide targeted support to these pupils and their families

Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these $\stackrel{\bullet}{\text { patterns }}$

### 7.3 Using data to improve attendance

The Headteacher will
Provide regular attendance reports to classteachers and other school leaders, to facilitate discussions with pupils and families

Use data to monitor and evaluate the impact of any interventions put in place in order to modify them and inform future strategies

### 7.4 Reducing persistent and severe absence

Persistent absence is where a pupil misses $10 \%$ or more of school, and severe absence is where a pupil misses $50 \%$ or more of school.

The school will:

- Use attendance data to find patterns and trends of persistent and severe absence

Hold regular meetings with the parents/carers of pupils who the school (and/or local authority) considers to be vulnerable, or are persistently or severely absent, to discuss attendance and engagement at school

- Provide access to wider support services to remove the barriers to attendance

The school work with the pupil welfare service to monitor and intervene with those who are persistently late or absent after the close of the register.

## 8. Monitoring arrangements

This policy will be reviewed as guidance from the local authority or DfE is updated, and as a minimum every 2 years by Headteacher At every review, the policy will be approved by the full governing board.

## Appendix 1: attendance codes

The following codes are taken from the DfE's guidance on school attendance.
